- (4) During periods of Prorationing, each Uncommitted Shipper Rate per barrel shall at all times be [U] \$0.54, which is one cent (\$0.01) below the lowest prevailing Committed Shipper Rate for each respective service route.
- (5) All rates are subject to adjustment each July 1 in accordance with 18 C.F.R. § 342.3 or any successor methodology adopted by the Federal Energy Regulatory Commission.
